Requirements for 1st Year Students: Follow the instructions in each box.

Leadership Development Experiences

Must choose at least one:

- Leadership Coaching** (Advanced Assessment and Leadership Development Plan required)
- Serve on a committee of a nonprofit Board (opportunities are competitive and process is initiated by student)
- Leadership in Action Experiences
- Serve as an Officer, Committee Chair, or Project Coordinator on campus (credit given in either developmental experiences or community service)
- Political Leadership Institute (Attend 2-day session)

***First-year students are eligible for coaching in the second semester*



Programs

Choose a minimum of three:

- Bright House Lunch & Learn
- Bagels with the Board
- Leadership Book Club
- Leadership Speaker Series
- Launch and/or lead a club or organization on campus
- Toastmasters (attend a minimum of 3 meetings)
- Other leadership event or experience on/off campus

Note: After participating in one Leadership Development Experience, a second one may be used to substitute a program.



Community Service

Minimum 8 hours of documented participation in one of the following:

Project A

- Participate in CLD sponsored Community Service Day(s)

OR

Project B

Participate in one of the following:

- Serve on CLD Advisory Board
- Serve on community service project related to MBA Nonprofit Board
- Serve as an Officer, Committee Chair, or Project Coordinator on campus (credit given in either developmental experiences or community service)
- Serve on a Community Service Project on/off campus in a leadership role

Requirements for 2nd Year Students: Follow the instructions in each box.

Academic Experiences

MGT 610 (Leadership)

Note: Completion of MGT 610 and 1st year Road Map requirements will qualify students for 2nd year recognition

Note: 2nd year students who did not meet the 1st year Road Map requirements may qualify for recognition in their 2nd year by completing MGT 610 and one Leadership Development Experience

OR

Leadership Development Experiences

Choose a minimum of two:

- Leadership role in a consulting project (MBA 611 or INTL 604; requires documentation of leadership role from professor)
- Leadership Coaching based on development plan
- Leadership in Action Experience
- Launch and/or lead a club or organization
- Continue serving on MBA Nonprofit Board (open only to current board members)
- Leadership role in a community service project(s) on/off campus (includes Officer, Committee Chair, or Project Coordinator)
- Serve on CLD Advisory Board (limited to six 2nd year students)
- Serve in leadership role for CLD Community Service project
- Toastmasters (present more than one speech or serve as an officer)
- Plan and facilitate a leadership event(s) on/off campus
- Leadership Book Club (lead discussion)
- Political Leadership Institute (attend 2-day session)
- Other leadership events or experiences on/off campus, and/or leadership position in a work environment

Requires documentation from organization, unless sponsored by CLD
